Dear Parents and Community Members:

We are pleased to present you with the Annual Education Reports (AER) which provides key information on the 2019-2020 educational progress for HCS' Alternative Education Programs: LEGACY High School and Hartland Virtual Academy. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. If you have questions about the AER please contact Nicole Conley for assistance.

For the 2019-2020 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given a label.

Hartland Virtual Academy understands that connections are crucial to academic success. Teacher mentors work extensively to create a virtual connection that can lend itself to social emotional health, scholastic achievement and sense of belonging to the Eagle Community.

LEGACY staff members are innovative relationship builders that understand various challenges that come with students' educations. Efforts can include non-academic areas of support like social emotional presentations and counseling groups as well as individualized instruction with the classroom. We always consider students' confidence and the tools needed to acquire self-awareness, positive character, and life-long learning skills that are relevant for post secondary success.

State law requires that we also report additional information.

Since 1982, Hartland Consolidated Schools has offered a non-traditional avenue, LEGACY High School, for students to earn a diploma and the district expanded its alternative education institutions in 2011 with the addition of Hartland Virtual Academy. Both programs enroll school of choice students, offer flexibility and opportunity for meaningful connection as well as post secondary planning. LEGACY delivers instruction in a standard classroom setting while HVA's primary mode of delivery is virtual. Students enrolled at LEGACY attend school daily, and HVA learners connect bi-weekly with their mentors with the option to attend an in-person study/computer lab. Both schools have School Improvement Plans and goals are aimed at helping all students demonstrate proficiency in math, reading, writing, and social emotional learning. Hartland Consolidated Schools, including LEGACY and HVA, has moved away from the traditional parent-teacher conference night format. In lieu of a single conference, parents have access to student performance data through our student information system for constant information, monitoring and school-to-home collaboration about their students' progress. Additionally, educators are available to meet throughout the year and over Zoom, when a parent and/or the teacher requests such meetings.

LEGACY and HVA are schools of choice as flexibility and opportunity are the guiding ideologies of alternative education. Students enter the programs through enrollment meetings that discuss student interests and placements as well as standard policies and procedures. Students in Alternative Education maintain the ability to dual enroll in college, access Early Middle College openings, register with share time opportunities in conjunction with accomplishing high school graduation requirements. Curriculum documents are available on the website as well as course catalogs for the virtual classes.

LEGACY High School had 1 student participate in dual enrollment in 2018-19 (1% of students). LEGACY High School had 3 students participate in dual enrollment in 2019-20 (8% of students).

Hartland Virtual Academy had 2 students participate in dual enrollment in 2018-19(4%). Hartland Virtual Academy had 3 students participate in dual enrollment in 2019-20 (9%).

Both LEGACY High School and Hartland Virtual Academy offer two different online platforms. One platform boasts over 290 class offerings including 48 AP courses, and the other platform provides students with just over 70 choices.

LEGACY did not have students participate in AP courses in 2018-19. LEGACY had 1 student, or 1% of students in 12th grade, participate in AP courses in 2019-20.

HVA had 2 students, or 4% of students, participate in AP courses in 2018-19. HVA had 2 students, or 6% of students participate in AP courses in 2019-20.

Premier school districts provide programs for all learners, regardless of circumstance, and HCS does just this - giving opportunity to excel and providing remediation to those in need ensuring all levels of learning are available to all students. HCS continues to look for cutting edge, twenty-first century educational opportunities to bring to its community.
